risk and reward profile



Risk indicator is presented in accordance with the Key Information Document. The indicator is calculated based on the historical volatility of the subfund's rates of return resulting from the implemented investment policy and may change in the future. Even the lowest risk category does not mean that the sub-fund is risk-free. investor profile

The subfund is intended for investors seeking an alternative to investing independently in units or shares outside Poland, who are willing to accept a high level of investment risk that may potentially result in gains over the longer term.

The subfund may be suitable for regular investing within long-term savings and pension schemes (regular savings plans (CPO), individual retirement accounts (IKEs), individual pension security accounts (IKZEs) and employee pension schemes (PPEs).

The assessment of the subfund's management performance should be made over a period of at least five years.

investment process

The subfund invests at least 80% of its assets in shares of **Amundi Core MSCI World UCITS ETF** (the "underlying subfund"), a subfund of **Amundi ETF ICAV**.

Up to 20% of its assets may be invested in debt securities and money market instruments specified in the Articles of Association, up to 20% in deposits, and up to 20% in other units and fund interests, subject to the conditions set out in the Articles of Association.

The underlying subfund is passively managed. The objective of the subfund is to track the performance of the MSCI World Index (the "Index"). The Index is a broad global equity index representative of the large and mid-cap markets across developed countries. The Index is a net total return index, meaning that dividends net of tax paid by the index constituents are included in the Index return. The exposure to the Index will be achieved through a Direct Replication, mainly by making direct investments in transferable securities and/or other eligible assets specified in the underlying subfunds' prospectus. Except for permitted investments in over-the-counter (OTC) derivatives, such as options and swaps, and cash, the investments of the foreign subfund will comprise equities and equity-related instruments that are listed and traded on regulated markets. The Investment Manager will be able to use derivatives, options and swaps linked to the equities which relate to the Index or constituents of the Index in accordance to the investment goal.

The investment objective of the subfund is to increase the value of its assets through the appreciation of its investments. The subfund does not guarantee that its investment objective will be achieved or that any specific investment performance will be attained.

Under normal circumstances, the subfund will invest its entire portfolio in units of **Amundi Core MSCI World UCITS ETF** (model allocation).

The subfund is actively managed.

The fund applies currency risk hedging with the aim of eliminating the impact of exchange rate fluctuations on the final investment result.

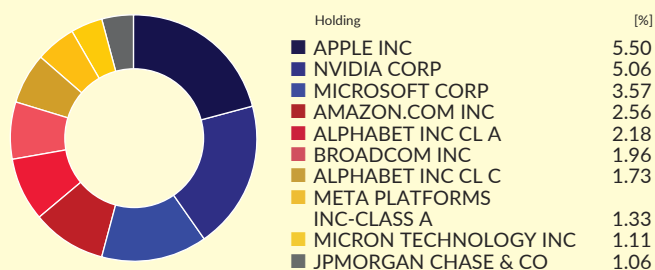
