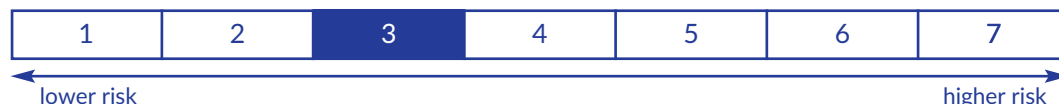


ESALIENS GLOBAL FIXED INCOME MULTI STRATEGY

risk and reward profile



Risk indicator is presented in accordance with the Key Information Document. The indicator is calculated based on the historical volatility of the subfund's rates of return resulting from the implemented investment policy and may change in the future. Even the lowest risk category does not mean that the sub-fund is risk-free. Other risk factors related to investing in the sub-fund, which are not included in the indicator, are presented in the Key Information Document and the Fund Prospectus.

investor profile

The sub-fund is targeted at an investor who:

- is seeking to achieve a rate of return higher than global debt securities indices within 2-year periods;
- is looking for a fund with an active and flexible investment policy focused on opportunities;
- accepts moderate investment risk associated with investments in government and non-government debt securities issued in different countries and denominated in different currencies.

The sub-fund may be intended, among other things, for systematic savings within long-term saving and pension programmes (CPO, IKE, IKZE).

The sub-fund performance should not be assessed in periods shorter than 2 years.

investment process

Model structure: 100% – units of the **Legg Mason Western Asset Global Multi Strategy Fund**, sub-fund operating within the framework of Legg Mason Global Funds plc (an umbrella fund registered in Ireland). Underlying sub-fund, the Legg Mason Western Asset Global Multi Strategy Fund, invests primarily in debt securities denominated in U.S. dollars, Japanese yen, pounds sterling, euros and other developed and developing market currencies.

The objective of the sub-fund is to generate capital appreciation by increasing the value of its investments. The sub-fund tracks as closely as possible the performance of the **Legg Mason Western Asset Global Multi Strategy Fund**. The sub-fund is actively managed. The participation titles of the underlying sub-fund are purchased by the sub-fund in PLN and should be hedged against currency risk in relation to the currency of the underlying sub-fund.

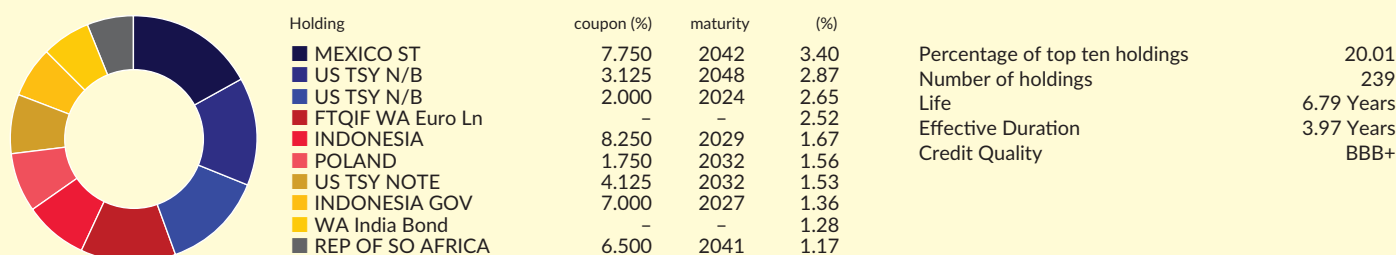

Credit quality breakdown, country allocation, currency exposure, sector breakdown, top ten holdings – the data refers to the underlying sub-fund as of 31 Jan 2023. Percentage values are based on total portfolio as of month-end and are subject to change at any time.

definitions

Life: The average number of years for which each component of unpaid principal on a bond, loan or mortgage remains outstanding. The weighted average life calculation provides an aggregate figure that shows how many years it will take to pay off half the outstanding principal on a bond portfolio.

Effective duration: Average Duration equals the weighted average maturity of all the cash flows in the portfolio and gives an indication of the sensitivity of a portfolio's bond prices to a change in interest rates. The higher the duration, the more sensitive the portfolio is to interest rate changes. Effective Duration is a calculation for bonds with embedded options (Not every portfolio will purchase bonds with embedded options). It takes into account the expected change in cash flows caused by the option, as interest rates change. If a portfolio does not hold bonds with embedded options, then the Effective Duration will be equal to the Average Duration.

Credit quality breakdown: ationally Recognised Statistical Rating Organisations (NRSROs) assess the likelihood of bond issuers defaulting on a bond's coupon and principal payments. The weighted average credit quality by Western Asset Management assigns each security the higher rating from three NRSROs (Standard & Poor's, Moody's Investor Services and Fitch Ratings, Ltd.). If only one NRSRO assigns a rating, that rating will be used. Securities that are not rated by all three NRSROs are reflected as such.

The lower the overall credit rating, the riskier the portfolio. The credit rating is expressed as a regular letter rating (from high to low quality): AAA, AA, A, BBB, BB, ...D.
